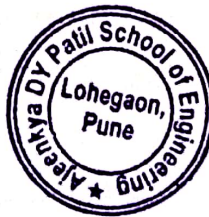

(1) Action Taken to resolve Item-1 (Scholarships Pending from GOI):

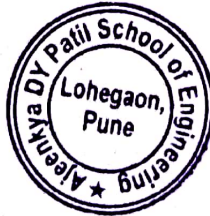
Students are permitted to take admission in next year without clearance in fees.
