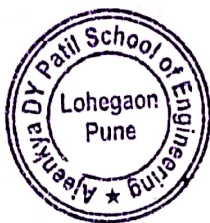

1. Review of Dr. Babasaheb Ambedkar Jayanti Celebration – 17 April 2025

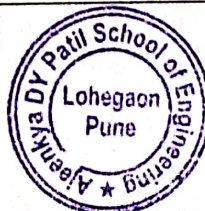
- The celebration of Dr. Babasaheb Ambedkar Jayanti on 17 April 2025 was well organized and successfully conducted in the college.

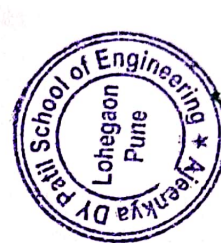

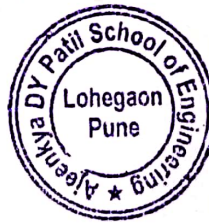
SC/ST-OBC Grievance Redressal Committee
