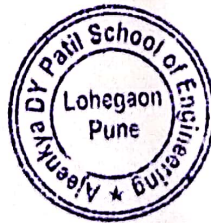

**Meeting Location:** Conference Room No 18

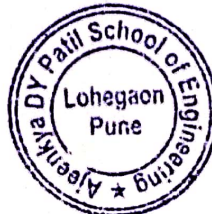
A meeting of SC/ST- OBC Grievance Redressal Committee will be held on 6<sup>th</sup> Sept 2024 at Conference room no. 18.
