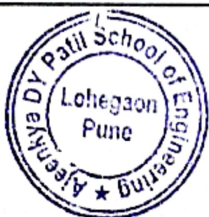

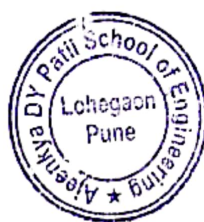

MEMORANDUM OF ASSOCIATION

This Memorandum of Agreement is made in Chandigarh, India on 11th August 2023.

BETWEEN

Canamprep a Test prep division of Canam Consultants Limited, SC0 83-84 Sector 17-D, Chandigarh – UT, India. (Hereinafter referred to as "Canamprep" which term shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors and assigns) of the ONE PART.

AND

Ajeenkya D Y Patil School of Engineering, Charholi BK, via Lohegaon, Pune, Maharashtra, India. 412105, represented through its Director Technical Campus Dr. Kamajeet Kaur. (Hereinafter referred to as Associate) of the OTHER PART.

1. Definitions:

- a. "Canamprep" is an English Language Training Associate that offers training for IELTS, PTE, CELPIP, CAEL-CE, UKVI tests etc. Canamprep will be providing test preparation at the said Approved Location for the D. Y Patil University registered students.
- b. "Approved Location" means the physical premises identified as Ajeenkya D Y Patil School of Engineering, Charholi BK, via Lohegaon, Pune, Maharashtra, India. 412105.
- c. "Trademark" includes the trademark CANAMPREP trade names, service marks, commercial announcements (Slogans) and related insignia (Logos), goodwill associate with the marks, Immigration documentation procedures, unique informed Presentation, Reporting System, Forms, policies, trade secrets, knowledge, techniques, development & promotional material, software and technical data.
- d. "Student/Client" means any student registered with Ajeenkya D Y Patil School of Engineering and is willing to prepare for IELTS, "Canamprep" will provide the required Coaching's.
- e. "Term" means the duration of this Agreement.
- f. "Ambience" means the designs and the layout pertaining to specific and unique interior and exterior design(s) provided by Canamprep. The typical display of Canamprep, furniture fixtures accessories etc.
- g. "Class" means a single Offering of a Program, for example an IELTS test preparation course that meets on specific dates and times for a specific duration.
- h. "Digital Assets" means content and functionality for Canamprep programs that is accessible via the Internet or app, including but not limited to videos, question banks, online practice tests, online instruction and explanations, images and audio files.

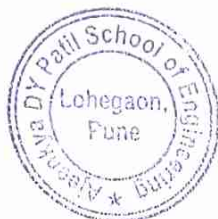
- i. "Offer" means to offer to sell, sell or otherwise provide access.
- j. "Program Materials" mean all materials relating to the Approved Programs, including course books, lessons, tests, question booklets, instructor lesson plans, library materials, marketing materials, and any copies or translations provided by Canamprep. "Program Materials" also includes Digital Assets, computer files in any format, e-books, computer disks, software or other computer applications, including content provided via media server, to the Approved Programs and/or to the Authorized Programs.
- k. "Teach" means to instruct, teach, advice, tutor, train or educate Students

2. APPROVED LOCATION:

- a. That Associate will provide the furnished space as mentioned in the Annexure B at the said location for IELTS preparation and Counselling at, **Ajeenkya D Y Patil School of Engineering**, Charholi BK, via Lohegaon, Pune, Maharashtra, India. 412105.
- b. Associate will ensure that the Approved location is clean, suitable for the purpose, safe and compliant with all relevant laws.
- c. Associate will provide the space for displaying the Canam Signage and trademarks in such form and manner as per Canam specifications.
- d. That Associate will provide the following as per the Annexure B which includes Clean and hygienic Office space, Class rooms, Furniture, Fixtures, Electricity, water, sanitation, Air conditioning, Space for Boards, Signage, and adequate Internet bandwidth to access Digital content.
- e. Any costs to furnish center with the required Furniture, Fixtures, equipment, maintenance & support of the required equipment shall be borne by the associate.

3. GRANT OF RIGHTS

- a. As per this agreement it is acknowledged by both the parties to start Canamprep IELTS preparation at the said location **Ajeenkya D Y Patil School of Engineering**, Charholi BK, via Lohegaon, Pune, Maharashtra, India. 412105, in which the company will establish the system which includes confidential and proprietary information to operate and provide services to the registered students of Ajeenkya D Y Patil School of Engineering or other students of the University Campus.
- b. The Company and Associate, understands and agrees to be bound by the terms, conditions and obligations as mentioned in "**Annexure A & B**" of this agreement.
- c. This Agreement does not grant the Associate any permanent territorial rights of the Company and its affiliates have unlimited rights to cancel the agreement with immediate effect in case of non-conformity to the terms and conditions.

- d. That the Associate does not have the power to sub-license, sell or sub let the services or any part thereof to any other party.
- e. For the consideration and upon the other terms and conditions hereinafter provided. Canamprep will provide trained and experienced staff with proprietary system as per **Annexure A** for establishing and operating the **"Canamprep" Testprep** center in the **Ajeenkya D Y Patil School of Engineering**.
- f. That the Company will recruit, hire, train, terminate and supervise all the **"Canam/Canamprep"** employees, set pay scales and timely pay all wages and related amounts including any employment benefits, taxes or other statutory expenses and the Associate will not have any responsibility for these matters. The employees will always remain on the Company's pay rolls / records.
- g. That Associate is agreed that the fees or charges required to be paid by the clients/students for services shall be prescribed by the Canamprep and shall be collected and receipts generated by Canamprep. Canamprep will take care of the GST and other taxes for the said fee. All inter office, intra office and client interactions will be as per the company's norms and policies.
- h. Prescribed special offer fee for IELTS preparation shall be 9000/- per month. Class shall be for 2 hours per day other than standard and University Campus holidays.
- i. Fee will be increased by 15% every year.
- j. That Company will provide effective and efficient services to all prospective students/clients of Ajeenkya D Y Patil School of Engineering and other students in University Campus.

4. TRADEMARKS & COPYRIGHTS

- a. Canam Consultants Limited grants a non-exclusive, revocable right to be used in the campus. Upon Termination of this Agreement, right to use Canamprep' name and all names, logos, insignia and other trademarks related to Canamprep, and Materials ("Canamprep Marks") immediately terminates.
- b. That the Associate acknowledges the validity of the Canamprep Marks, and Copyrights (collectively, "Intellectual Properties"), and Associate acknowledges that Intellectual Properties are exclusively owned by Canamprep and Associate has no right to use, and agrees not to use, Intellectual Properties other than as expressly provided in this Agreement. Associate acknowledges that all good will in the Marks, including goodwill developed during the Term, belongs exclusively to Canamprep.

5. CONFIDENTIALITY

- a. Associate will ensure that its shareholders, employees, officers, directors, agents and contractors will, keep and maintain secret and confidential the methods, processes,

systems, techniques, information, knowledge, Know-How, trade practices, Program Materials and all related materials, secrets and any other business information (collectively, "Confidential Information") divulged, disclosed or in any way communicated by Canamprep to Associate. Any breach of this Article by any of Associate's shareholders, employees, officers, directors, agents and contractors will be deemed a breach by Associate. If Associate is required by law to disclose any items or materials within the scope of Canamprep's Confidential Information to any governmental agency or authority, it will notify Canamprep and identify the specific material required to be disclosed and the purpose of the required disclosure and will offer reasonable cooperation to Canamprep in any efforts by Canamprep to defend against such disclosure.

- b. Associate will safeguard the Program Material provided by Canamprep. None of the Programs or Program Materials with the exception of those materials as designated by Canamprep "for use by students" or "for use by Canamprep's Staff". Associate further agrees specifically that Canamprep's sample material, Promotional material, Digital material, video's, software or other computer applications, including content provided by server whether onsite or offsite, will remain and be protected on its premises at all times and will not be duplicated by Associate, its agents, assigns, faculty, staff or students. Associate will require all of its employees, agents, related entities, students and third parties having access to said materials to agree in writing to the limited authorized use.

6. INDEMNIFICATION & LIMITATION OF LIABILITY

- a. Associate holds Canamprep harmless of and from, and indemnifies Canamprep from any and all, losses, liability, damages, taxes, charges, penalties, fees and expenses, including reasonable attorneys' fees, (collectively "Harms"), which Canamprep may incur or be obligated to pay, or for which Canamprep may become liable or be compelled to pay, in connection with any action, claim or proceeding ("Claim") arising out of any act, whether of omission or commission, by Associate, or by any of Associate's Personnel, shareholders, directors, employees, affiliates, contractors, servants, or agents, including any act, whether of omission or commission relating to the operation at the Approved Location. Associate also indemnifies Canamprep from all harms arising from any claim alleging that personnel are employees, agents or representatives of Canamprep in the performance of their services to, or on behalf of, or at the direction of Associate.
- b. Canamprep holds Associate harmless of and from, and indemnifies Associate from any and all, harms which Associate may incur or be obligated to pay, or for which Associate may become liable or be compelled to pay, in connection with any Claim against Associate that Associate's use of Intellectual Properties under the terms of this Agreement infringes upon the trademark, trade name or other rights of a third party. Such indemnification will be deemed to apply solely to (a) the amount of the judgment, if any, against Associate, (b) any sums paid by Associate in settlement, and (c) the expenses incurred by Associate in connection with its defense. Such indemnification by Canamprep will not apply to any damages sustained by Associate by reason of such infringement other than those specified above, and in no event will apply to consequential damages.

- c. Any Party seeking indemnification pursuant to this Article must give the other Party prompt written notice of any such action, claim or proceeding and the indemnifying Party, in its sole discretion, then may take such action as it deems advisable to defend such action, claim or proceeding on behalf of the other Party. If appropriate action is not taken by the indemnifying Party within 30 days after its receipt of notice from the other Party, the other Party will have the right to defend such action, claim or proceeding, but no settlement may be made without the approval of the indemnifying Party, which approval will not be unreasonably withheld. In either case, Associate and Canamprep will keep each other fully advised of all developments, will provide each other with copies of all documents exchanged in court, and will cooperate fully with each other in all respects in connection with any such defense as is made. Canamprep may act independently for the protection of its rights and interests vis-a-vis third parties, with the possibility, in such instance, for Canamprep to bring its own counsel, at its own expense, into any suit instituted or intervene directly.

7. TERM & TERMINATION

- a. This Agreement shall be deemed to have come into force and effect from 11th August 2023. Unless otherwise terminated in accordance with the provisions of this Agreement, the term of this Agreement shall be for a period of **3 (Three) Years** effective from 11th August 2023.
- b. The Agreement shall automatically terminate at the end of the Term unless renewed by a valid amendment. For the avoidance of doubt, associate has no right of renewal nor any right of first refusal or right to good faith negotiations concerning renewal or amendment, and any renewal or amendment of this Agreement required the mutual consent.
- c. That Ajeenkya D Y Patil School of Engineering agrees that throughout the duration of this agreement the International Education Center will be an exclusive Canam Office and no other similar business activity will be done within the Campus premises by Ajeenkya D Y Patil School of Engineering or any other consultant / IELTS preparation institute. The Associate agrees that if there is any information of the (Associate conducting any business activity) received by the Company, the Company can immediately terminate the agreement (and the Associate will no longer be an associate of the Company). Company would in no way be involved in any such activity which would be termed as an activity carried out as the personal endeavors of the Associate.
- d. That Ajeenkya D Y Patil School of Engineering will not own or operate any other parallel consulting business at the said location or anywhere, directly or indirectly, during the term of this Agreement and for 3 (three) years after the termination of the Agreement, similar to the business reasonably contemplated by this Agreement except as the Company's duly licensed center at a said location.

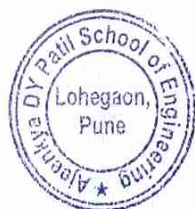


8. **POST TERMINATION PROVISIONS:**

- a. If Canamprep terminates this Agreement, Associate's rights to be or refer to itself as Associate, to Offer Programs and to use any Intellectual Properties shall automatically terminate. The same shall be true even if such termination is invalid and/or unlawful under this Agreement and/or under applicable law, in which case Associate's sole remedy shall be monetary damages. Associate acknowledges and agrees that once Canamprep provides a notice of Termination to Associate, Associate must permanently desist from any of the activities described in this paragraph. Associate does not acquire any economic goodwill value associated with being an Associate in accordance with this Agreement.
- b. Within 15 days of termination, all the manuals, marketing and promotional materials, all program materials, Systems, computers related with Canamprep in Associate's possession at the time of termination will be delivered to Canamprep. Canamprep has the right to visit Associate's offices to remove any of the said material or content on media server.
- c. The termination of this Agreement will not rescind or give rise to any rights to rescind anything done or any payment made or other consideration given to either Party prior to the time the Agreement terminated. The termination will be without prejudice to Canamprep's right to legal and equitable remedies for Associate's breach of its obligations under this Agreement.
- d. After the termination of this Agreement, Associate and all related entities, shareholders, directors, employees and any agents of Associate agree to a continuing obligation to use their best efforts to protect and safeguard the Intellectual Properties of Canamprep as provided in this Agreement.

9. **NON-COMPETITION**

- a. In exchange for its appointment as an Associate, Associate agrees that during the Term, Associate will not directly or indirectly offer, provide, advise or refer any student products or services:
 - (i) In connection with any services which Canamprep provides (e.g., Language or TEST Preparation) of their own or of other company or of a Canamprep's competitor, (collectively "Compete with Canam"). Associate shall mean: Associate; any parent companies, subsidiaries, affiliates, joint-ventures and group companies of Associate; and any companies whose ultimate ownership overlaps with Associate ultimate ownership or are under common control
- b. If Canamprep offers to renew or extend this Agreement at the end of the Term on substantially similar terms to this Agreement and Associate declines such renewal or extension, for a period of two years immediately following Termination Associate may not compete with Canamprep, unless otherwise agreed by Canamprep in writing.



- c. The parties agree to first notify each other in writing of any dispute. The written notification will specify, to the fullest extent possible, the notifying party's version of facts and all elements of the dispute. If the parties do not resolve the dispute within thirty (30) days after receipt of the notice of the dispute, the parties agree to non-binding mediation and to in good faith use best efforts to resolve the dispute. The parties will share the costs of the mediation equally and all discussion, negotiation, finding or other statements by the mediator and/ or the parties in connection with the mediation whether oral or written will not be admissible in evidence in any arbitration or litigation proceedings. If the parties do not resolve the dispute after mediation proceedings, the Company or the Associate may commence arbitration and each party will be responsible for its own costs, including lawyer's fees in any mediation, arbitration or court proceedings.

10. FORCE MAJEURE:

The obligations of the Parties will be subject to all laws, both present and future, of any government having jurisdiction over the Parties, and to orders, regulations, directions or requests of any such government, or any department or agency, and to war, whether or not declared, acts of public enemies, strikes or other labor disturbances, fires, floods, acts of God, acts of terrorism or mass crime, whether domestic or foreign and whether or not directed specifically at the Parties or the Parties' property, or any causes of like or different kind beyond the control of the Parties and, except as hereinafter provided, the Parties will be excused from any failure to perform any obligation under this Agreement to the extent and for such period of time that such failure is caused by any such law, order, regulation, direction, request or contingency. However, Associate will not be excused by any such law, order, regulation, direction, request or contingency from its obligations to furnish the statements and to make the payments provided for in this Agreement. Canamprep may terminate this Agreement if Associate performance under this Agreement is suspended due to a force majeure condition continuing for a period exceeding 6 months.

11. JURISDICTION

The Chandigarh shall have exclusive jurisdiction to try any disputes between the Parties.

12. ARBITRATION

In the event of a dispute, the Company and Associate are to make every effort to resolve the matter between the two parties. In the event a resolution cannot be reached, both Client and Firm agree that the subject matter will be referred to the sole Arbitrator, Mr. Balwinder Singh Jolly, Advocate Punjab and Haryana Court. Furthermore, this agreement is as per the Arbitration and Conciliation Act 1996. The Arbitration proceedings shall be held at Chandigarh.

All notices or other communications pursuant to this Agreement will be in writing and will be deemed valid and sufficient if delivered by personal service or courier or if dispatched

MEMORANDUM OF UNDERSTANDING

This **Memorandum of Understanding** (hereinafter called as the 'MoU') is signed on 7th of August 2023

Ajeenkya DY Patil School of Engineering, Pune, Charoli Bk. via Lohegaon, District Pune - 412105, Maharashtra, India the **First Party** represented herein by its **Director Dr. Kamaljeet Kaur and Principal Prof. Dr Farook Sayyad** (hereinafter referred as '**First Party**', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

AND

Indeed Inspiring Infotech a registered proprietorship firm, **Registered Address at - Sr.No.48/2 Plot no.4, First floor, Near FED bank (Landmark-Vijay Sales), Chandan Nagar, Kharadi, Pune-411014, the Second Party**, and represented herein by its **Founder & CEO, Mr. Kushal Sharma**, (hereinafter referred to as "**Second Party**", company which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

WHEREAS:

- A) First Party is a Higher Educational Institution named:
- (i) **Ajeenkya DY Patil School of Engineering, Pune, Charoli Bk. via Lohegaon, District Pune - 412105, Maharashtra, India**



- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.
- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest.
- E) **Indeed Inspiring Infotech**, the Second Party is engaged in providing software solution and IT services globally.
- F) **Indeed Inspiring Infotech** as a part of its Corporate Social Responsibilities (CSR) activities desires to collaborate with Ajeenkya DY Patil School of Engineering for promoting special education and employment enhancing vocational skills ("hereinafter referred to as Programme") among children undergoing under graduation Courses in engineering, So as to attain them a level as expected by IT industry for job functioning.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MoU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1 CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing



significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry, the Second Party.

- 1.3 The general terms of co-operation shall be governed by this MoU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MoU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MoU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2 SCOPE OF THE MoU

- 2.1 The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. - 2.1. **Student Internship:** Internship will be given by Ananta Farms to the students for practical understanding in civil in engineering of structural audit and material testing .



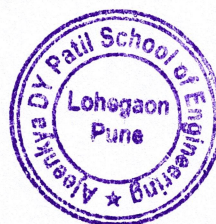
- 2.2. Industrial Visits:** Ananta Farms will organize site visits for students to the construction industries for acquiring knowledge of structural audit to be performed in the field.

I am a mentor for the JSPM Group at present and also visit institutes for mock accreditation and NEP awareness. I also do consulting for Built Environment.



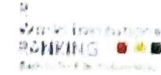
