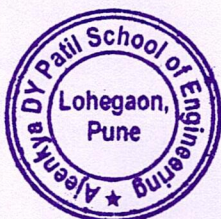


Agenda 1: Approval of Previous Minutes of Meeting No.2, dated 01-11-2023 & Action

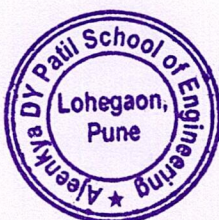

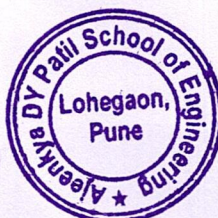

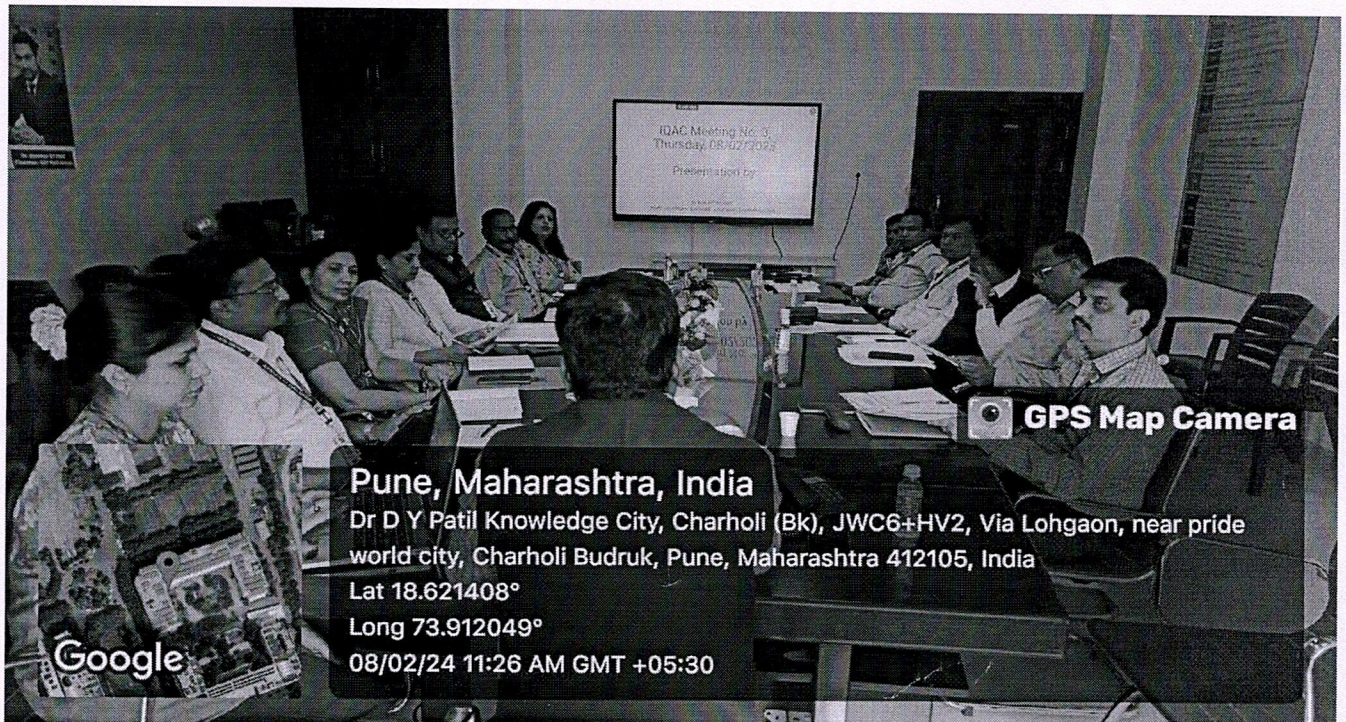


Agenda 9: Transformative Reforms for Strengthening Assessment & Accreditation

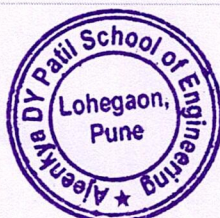

2] Adherence to Academic Calendar A.Y. 2023-24:

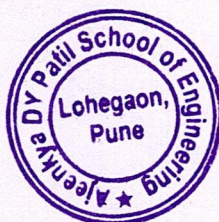
Action Taken: IQAC Chairperson has taken review from Dean Academics on the Planned and Conducted activities of academic calendar.

Outcome: An average of 50% of planned activities were executed by the Head of departments. It has been advised to immediately plan and conduct DAB meeting.


7) Transformative Reforms for Strengthening Assessment & Accreditation: A Discussion
