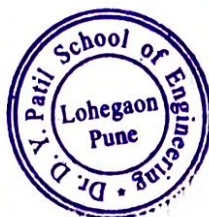

## DEPARTMENT OF CIVIL ENGINEERING

### GUEST LECTURE REPORT

Department of Civil Engineering organized a Guest Lecture on “**Gender Bias in the Society and Its Remedies**” on 06th May 2021 from 1:00 PM to 3:00 PM. It was conducted on Online platform Microsoft Team app. The guest lecture gather eminent speaker: Dr. Smita Awachar, Professor, Dr. B. A. M. University, Aurangabad. The lecture was attended by 70 students and 12 Faculty members of Civil Engineering Department.

The guest speaker was heartily welcomed by Mr. Uday Kakdde, a faculty of Civil Engineering Department. In the lecture, Dr. Awachar cited the assessment which measured to what extent women have achieved equality with men. She stated that the gaps between men and women in the health dimension have been closed, as well as 95% for educational attachment. However, very small percent of economic participation gap has been closed, and even smaller for political participation. She also examined the variation between gender inequalities across countries

Dr. Awachar argued that the problem of gender inequalities lies behind the bias of expectation, such as the assumptions that men would be more suitable for the leadership role. This stereotypical effect would have implications for the gender wage gap. Then, she explained the link between economic development and gender inequality. For example, women empowerment would correlate with beneficial family outcomes such as child health, nutrition and education. She also cited concept such as Household Bargaining Model on proving how female role affects family welfare. Lastly, she also reflects what kinds of policy intervention that would support gender equality

Finally, the guest lecture ended with a QnA session. We very much thanks to Dr. Smita Awachar, for shedding lights on the link between gender inequality and economic development to all the students and faculties aswell. The knowledge given would hopefully be a guidance for academics and in day to day life aswell.

The vote of thanks was given by Mr. Ahinsak Taksande, Faculty from Civil Engineering Department and Lt. Col. Sanjay M. Karodpati, HoD, Civil Department presented a small token of appreciation to our valuable guest.

As per the feedback received from the participants it was very good learning experience, the lecture helped them in their understanding the Gender Bias related issues and their remedies.

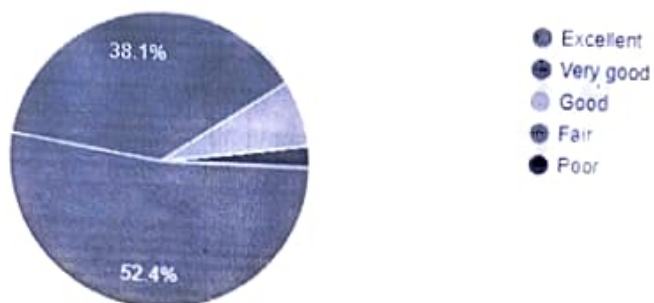

### **Annual Gender Sensitization Action Plan**

### **Guests**

### Anti-Ragging Policy

Government/University Grants Commission (UGC), guidelines notified vide no.F.1-16/2009 (CPP-II) dated 21-10-2009 on Curbing the Menace of Ragging in Higher Educational Institutions, 2009 (Under Section 26(1) (g) of the University Grants Commission Act, 1956) are strictly implemented at Dr D Y Patil School of Engineering, Lohegaon, Pune.

- (1) Anti-Ragging Squad shall be constituted to prevent ragging in the institution. The committee details are mentioned on website at <https://dypsoe.in/img/ARC.PDF>.
- (2) Anti-Ragging Squad shall make surprise raids at vulnerable places like hostel, washrooms, canteen, sports grounds etc.
- (3) Students and Parents shall submit Anti Ragging Affidavits to the institution at the time of admission.
- (4) Anti-ragging Awareness Programs shall be conducted in the institution.
- (5) Fresher and senior students shall be given information about Anti-Ragging Act during Orientation Program.
- (6) Students are encouraged to report any ragging act witnessed or experienced by them to anti-ragging squad or to any staff member with whom the student may feel comfortable. The institute will ensure confidentiality of such a disclosure by the student.
- (7) If any ragging case is reported, depending upon the nature and severity of the offence, the possible punishments as per AICTE / UGC Section 9 shall be given to those found guilty.

## **Rules & Regulations for Prevention and Prohibition of Ragging**

The All India Council For Technical Education (AICTE), New Delhi vide its Notification no. 37-3/Legal/AICTE/2009 dated 25-03-2009 has taken a very serious view of ragging incidences in educational institutions and on Directions of the Hon'ble Supreme Court of India vide its Order dated 16.5.2007 has ordered strict implementation of following rules & regulations for Prevention and prohibition of Ragging in technical Institutions.

### **Various Types of Ragging**

The Hon'ble Supreme Court has, inter-alia, mentioned the following types of ragging:-

1. Ragging has several aspects with, among others, psychological, social, political, economic, cultural, and academic dimensions.
2. Any act that prevents, disrupts or disturbs the regular academic activity of a student should be considered with in the academics related aspect of ragging; similarly, exploiting the services of a junior student for completing the academic tasks assigned to an individual or a group of seniors is also an aspect of academics related ragging prevalent in many institutions, particularly in the technical institutions.
3. Any act of financial extortion or forceful expenditure burden put on a junior student by senior students should be considered an aspect of ragging for ragging economic dimensions.
4. Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestured, causing bodily harm or any other danger to health or person can be put in the category of ragging with criminal dimensions.
5. Any act or abuse by spoken words, emails, snail-mails, blogs, public insults should be considered with in the psychological aspects of ragging. This aspect would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to others; the absence of preparing 'freshers' in the run up to their admission to higher education and life in hostels also can be ascribed as a psychological aspect of ragging – coping skills in interaction with seniors or strangers can be imparted by parents as well. Any act that affects the mental health and self-confidence of students also can be described in terms of the psychological aspects of ragging.
6. The human rights perspective of ragging involves the injury caused to the fundamental right to human dignity through humiliation heaped on junior students by seniors; often resulting in the extreme step of suicide by the victims.



**Actions to be taken against students for indulging and abetting in Ragging in technical institutions Universities including Deemed to be University imparting technical education:-**

1. The punishment to be meted out to the persons indulged in ragging has to be exemplary and justifiably harsh to act as a deterrent against recurrence of such incidents. The students who are found to be indulged in ragging should be debarred from taking admission in any technical institution in India.
2. Every single incident of ragging a First Information Report (FIR) must be filed without exception by the institutional authorities with the local police authorities.
3. Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the institution, the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following.
  - (i) Cancellation of admission
  - (ii) Suspension from attending classes
  - (iii) Withholding/withdrawing scholarship/fellowship and other benefits
  - (iv) Debarring from appearing in any test/examination or other evaluation process
  - (v) Withholding results
  - (vi) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
  - (vii) Suspension/expulsion from the hostel
  - (viii) Rustication from the institution for period ranging from 1 to 4 semesters
  - (ix) Expulsion from the institution and consequent debarring from admission to any other institution.
  - (x) Fine of Rupees 25,000/-
  - (xi) Collective punishment: when the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.
4. The institutional authority shall intimate the incidents of ragging occurred in their premises along with actions taken to the Council immediately after occurrence of such incident and inform the status of the case from time to time.
5. Courts should make an effort to ensure that cases involving ragging are taken up on priority basis to send the correct message that ragging is not only to be discouraged but also to be dealt with sternness.

## DEPARTMENT OF CIVIL ENGINEERING

### GUEST LECTURE REPORT

Department of Civil Engineering organized a Guest Lecture on “**Gender Bias in the Society and Its Remedies**” on 06th May 2021 from 1:00 PM to 3:00 PM. It was conducted on Online platform Microsoft Team app. The guest lecture gather eminent speaker: Dr. Smita Awachar, Professor, Dr. B. A. M. University, Aurangabad. The lecture was attended by 70 students and 12 Faculty members of Civil Engineering Department.

The guest speaker was heartily welcomed by Mr. Uday Kakdde, a faculty of Civil Engineering Department. In the lecture, Dr. Awachar cited the assessment which measured to what extent women have achieved equality with men. She stated that the gaps between men and women in the health dimension have been closed, as well as 95% for educational attachment. However, very small percent of economic participation gap has been closed, and even smaller for political participation. She also examined the variation between gender inequalities across countries

Dr. Awachar argued that the problem of gender inequalities lies behind the bias of expectation, such as the assumptions that men would be more suitable for the leadership role. This stereotypical effect would have implications for the gender wage gap. Then, she explained the link between economic development and gender inequality. For example, women empowerment would correlate with beneficial family outcomes such as child health, nutrition and education. She also cited concept such as Household Bargaining Model on proving how female role affects family welfare. Lastly, she also reflects what kinds of policy intervention that would support gender equality

The knowledge given would hopefully be a guidance for academics and in day to day life aswell.

As per the feedback received from the participants it was very good learning experience, the lecture helped them in their understanding the Gender Bias related issues and their remedies.

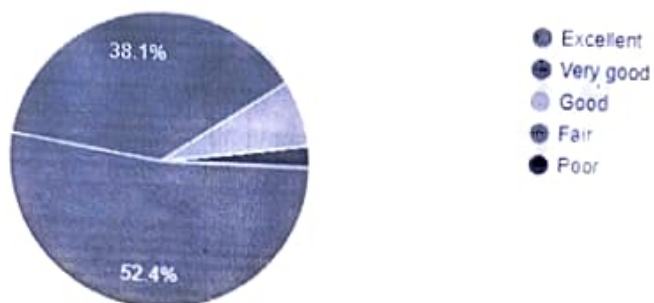

- Entry/Exit timings are to be maintained in the Security Register. This would be monitored on daily basis. (Last in time is at 10 p.m.) Two such notices shall be issued to those occupants who do not meet this deadline and a 3rd notice for the same shall call for an immediate eviction from Ajeenkya D Y Patil UniSpace.

### **Traffic**

- Student not to blow horn and play loud music inside campus.
- Student must park their vehicles at allotted parking area.
- Students must wear helmet.

### **Guests**

- Guests / parents / brothers / sisters / Friends of the student are not permitted to stay & enter in Rooms of Ajeenkya D Y Patil UniSpace.
- Visitors are allowed only between 11 a.m. and to 7.30 p.m. Their movement will be restricted up to the office area only. (No visitors can step into the bldg. area and no staying over is allowed)

### **Electricity**

- Lights must be switched off when not in use.
- The use of electric heater, immersion rod and other similar appliances are prohibited.
- Boarders are warned against tampering with electric installations. For all electric repairs the electrician must be called in.

### **Discipline**

- Students are expected to maintain perfect discipline and a healthy atmosphere in Ajeenkya D Y Patil UniSpace.



- All kinds of shouting, violent knocking or any other act of movement or behavior that is likely to cause disturbance or annoyance is strictly prohibited.
- No loud music especially "Bluetooth Speakers" while walking in the campus.
- Maltreating or abusing the employees and staff is strictly prohibited. Any case of misbehavior will result in immediate eviction of the student (s) and he/she will have to forfeit the fees paid.
- Dealing in general, especially with fellow students should be very courteous and polite. All disputes with fellow Hostlers should be avoided. Students must not take law in their own hands, and must report all disputes to the concerned officials.
- Any Hostlers found guilty of having committed a breach of rules shall be liable to be punished by the officials as under.
- Any damages done to room like breaking of furniture and fixtures, wall painting etc. will be recovered from the security deposit paid by the respective room students
- A written warning would be issued and a written apology will be sought from the concerned student.
- After two such warnings, if there is a repeat of offence, the concerned student will be immediately expelled from the Ajeenkya D Y Patil UniSpace accommodation and his / her fees paid will be forfeited.
- The Management reserves the right to refuse any applicant admission to Ajeenkya D Y Patil UniSpace. In matters of admission and discipline, the decision of the Management shall be final and binding.
- Acts of rowdyism, indiscipline, misbehavior with the Management, staff, security and occupants shall account for immediate eviction from the hostel.
- A head count would be taken at 10pm every night. Failing to be present in the rooms by this deadline would be considered as being absent from the premises and appropriate action would be taken accordingly.
- Nights - out are allowed only Prior permission from the Parents. No out pass will be issue after 9:00pm to students.

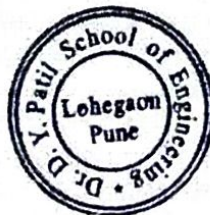

### **Anti-Ragging Policy**

Government/University Grants Commission (UGC), guidelines notified vide no.F.1-16/2009 (CPP-II) dated 21-10-2009 on Curbing the Menace of Ragging in Higher Educational Institutions, 2009 (Under Section 26(1) (g) of the University Grants Commission Act, 1956) are strictly implemented at Dr D Y Patil School of Engineering, Lohegaon, Pune.

- (1) Anti-Ragging Squad shall be constituted to prevent ragging in the institution. The committee details are mentioned on website at <https://dypsoe.in/img/ARC.PDF>.
- (2) Anti-Ragging Squad shall make surprise raids at vulnerable places like hostel, washrooms, canteen, sports grounds etc.
- (3) Students and Parents shall submit Anti Ragging Affidavits to the institution at the time of admission.
- (4) Anti-ragging Awareness Programs shall be conducted in the institution.
- (5) Fresher and senior students shall be given information about Anti-Ragging Act during Orientation Program.
- (6) Students are encouraged to report any ragging act witnessed or experienced by them to anti-ragging squad or to any staff member with whom the student may feel comfortable. The institute will ensure confidentiality of such a disclosure by the student.
- (7) If any ragging case is reported, depending upon the nature and severity of the offence, the possible punishments as per AICTE / UGC Section 9 shall be given to those found guilty.

## **Rules & Regulations for Prevention and Prohibition of Ragging**

The All India Council For Technical Education (AICTE), New Delhi vide its Notification no. 37-3/Legal/AICTE/2009 dated 25-03-2009 has taken a very serious view of ragging incidences in educational institutions and on Directions of the Hon'ble Supreme Court of India vide its Order dated 16.5.2007 has ordered strict implementation of following rules & regulations for Prevention and prohibition of Ragging in technical Institutions.

### **Various Types of Ragging**

The Hon'ble Supreme Court has, inter-alia, mentioned the following types of ragging:-

1. Ragging has several aspects with, among others, psychological, social, political, economic, cultural, and academic dimensions.
2. Any act that prevents, disrupts or disturbs the regular academic activity of a student should be considered with in the academics related aspect of ragging; similarly, exploiting the services of a junior student for completing the academic tasks assigned to an individual or a group of seniors is also an aspect of academics related ragging prevalent in many institutions, particularly in the technical institutions.
3. Any act of financial extortion or forceful expenditure burden put on a junior student by senior students should be considered an aspect of ragging for ragging economic dimensions.
4. Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestured, causing bodily harm or any other danger to health or person can be put in the category of ragging with criminal dimensions.
5. Any act or abuse by spoken words, emails, snail-mails, blogs, public insults should be considered with in the psychological aspects of ragging. This aspect would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to others; the absence of preparing 'freshers' in the run up to their admission to higher education and life in hostels also can be ascribed as a psychological aspect of ragging – coping skills in interaction with seniors or strangers can be imparted by parents as well. Any act that affects the mental health and self-confidence of students also can be described in terms of the psychological aspects of ragging.
6. The human rights perspective of ragging involves the injury caused to the fundamental right to human dignity through humiliation heaped on junior students by seniors; often resulting in the extreme step of suicide by the victims.



**Actions to be taken against students for indulging and abetting in Ragging in technical institutions Universities including Deemed to be University imparting technical education:-**

1. The punishment to be meted out to the persons indulged in ragging has to be exemplary and justifiably harsh to act as a deterrent against recurrence of such incidents. The students who are found to be indulged in ragging should be debarred from taking admission in any technical institution in India.
2. Every single incident of ragging a First Information Report (FIR) must be filed without exception by the institutional authorities with the local police authorities.
3. Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the institution, the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following.
  - (i) Cancellation of admission
  - (ii) Suspension from attending classes
  - (iii) Withholding/withdrawing scholarship/fellowship and other benefits
  - (iv) Debarring from appearing in any test/examination or other evaluation process
  - (v) Withholding results
  - (vi) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
  - (vii) Suspension/expulsion from the hostel
  - (viii) Rustication from the institution for period ranging from 1 to 4 semesters
  - (ix) Expulsion from the institution and consequent debarring from admission to any other institution.
  - (x) Fine of Rupees 25,000/-
  - (xi) Collective punishment: when the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.
4. The institutional authority shall intimate the incidents of ragging occurred in their premises along with actions taken to the Council immediately after occurrence of such incident and inform the status of the case from time to time.
5. Courts should make an effort to ensure that cases involving ragging are taken up on priority basis to send the correct message that ragging is not only to be discouraged but also to be dealt with sternness.

It is brought to the notice of all AICTE approved Institutions, students and other various stakeholders that ragging is a criminal offence and AICTE has already notified its Regulation vide F.No. 37-3/Legal/AICTE/2009 dated July 1, 2009 and subsequent amendments notified vide F.No. 37-3/Legal/AICTE/2009 & F.No. 34-AICTE/AR/Antiragging/2016 dated July 17, 2014 and February 22, 2017 respectively (available on AICTE web portal: [www.aicte-india.org](http://www.aicte-india.org)) on curbing the menace of ragging in AICTE approved Technical Institutions, in order to prohibit, prevent and eliminate the scourge of ragging in AICTE approved Technical Institutions.

The above Regulations are mandatory and applies to all AICTE approved Institutions. Therefore, all the Institutions should take necessary steps for its proper implementation such as:

- Constitution of Anti-Ragging Committee and Anti-Ragging Squad
- Obtaining Undertakings at the time of admission and at the time of allotment of Hostel
- Dedicated cadre of Warden(s) and regular visits to hostels
- Creating awareness through regular meetings with students
- Appointing Professional Counselor(s) for Freshers
- Erection of Poster/Banners displaying provisions of law, punishments etc.

Any violation of AICTE Regulations as cited above by an AICTE approved Institution or an instance wherein any Institution fails to take adequate steps to prevent ragging or fails to act in accordance with these Regulations or fails to punish perpetrators for incidents of ragging suitably, AICTE shall call for punitive action against erring Institutions as per provisions of the Approval Process Handbook.
